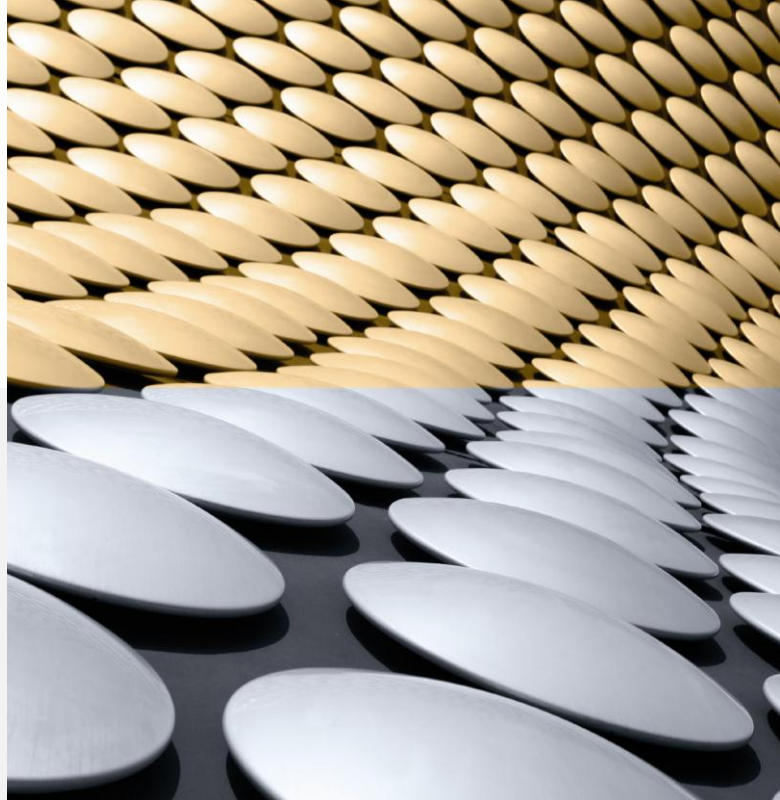

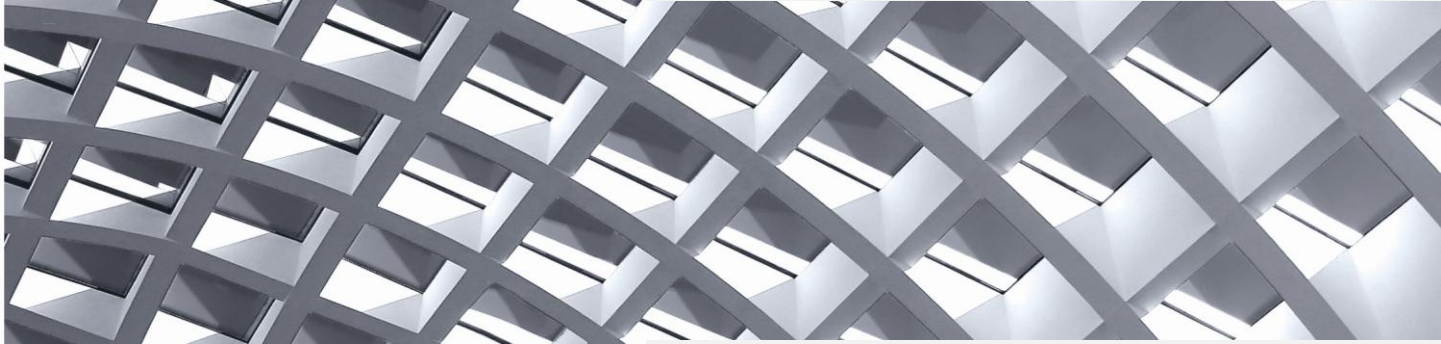
**Our office offers consulting service on Corporate and Commercial Law to our clients on a daily basis, especially about the following legal questions:**
